## FINANCE POLICY

### REGISTRATIONS

Registration of your child to play with Trinity Netball Club is to be completed online only. By proceeding and registering your child with Trinity Netball Club, you agree to the following terms and conditions:

Full payment of all registration fees must be made before the first game of the season unless a hardship plan has been agreed and entered into. If full payment is not received at this time, the player may not be eligible to train or play with the Club.

### REFUNDS

- All requests for refunds must be received in writing by email at [treasurer@trinitynetball.com.au](mailto:treasurer@trinitynetball.com.au)
- If your child withdraws from their nominated team prior to the start of the season, the Club will issue a 50% refund of club membership. Please note: This amount will be minus the Netball Victoria registration fee component as this is paid directly to Netball Victoria at the point of registration and the Club cannot apply for a refund.
- If you withdraw your child from the team after the commencement of the season, no refund will be issued.
- Non-attendance does not qualify for a refund.
- Cancellation – if training or a match is cancelled, no refund will be given.
- Illness & injury – no refund will be made for short term illness or injury. Members with a long-term illness or injury (that exclude the member for the majority season) may be eligible for a partial refund upon request in writing, accompanied by a medical certificate. This will be determined on a case by case basis, taking into account the number of weeks left in the season and the likelihood of replacing the member.
- Family holidays – inability to attend training or a match due to family holidays will not entitle the member to a refund.
- Suspension – absence due to suspension as a disciplinary measure will not entitle the member to any refund.



# TRINITY NETBALL CLUB

- Cancellation of a team – if the club is required to cancel a team and players cannot be accommodated elsewhere, the members will be offered a full refund of membership fees excluding the Netball Victoria registration fee
- Clothing and merchandise – purchase of items is through a supplier and there is no return policy with the supplier.

## FINANCIAL HARDSHIP

- A financial hardship payment plan will be considered by the President and Treasurer on a case by case basis. Requests must be received in writing (via email) at the start of any registration period. - A report of all received and outstanding fees will be completed by the Treasurer, with the assistance of the Registrations Officer, and provided to the President and Committee for review as/when requested at the following Committee meeting.
